HarborOne Bank Debit Card Promotion - "Dash for Cash" Sweepstakes

Official Rules

- 2. **Eligibility**: The "Debit Dash for Cash" Sweepstakes (the "Sweepstakes") is open to all HarborOne Bank customers, consumer and business, with a deposit account, who make point-of-sale transactions totaling \$2,000 or more using their HarborOne debit card during the Promotion Period. Customers must be in good standing with the Bank. Consumer customers must be age 18 or older. One entry per person.

The Sweepstakes is open to residents of the New England states (Massachusetts, Maine, New Hampshire, Vermont, Connecticut, and Rhode Island) except employees of advertising and promotion agencies and their immediate family (parents, grandparents, siblings, and children) and persons living in the same household of such employees, and employees of HarborOne Bank, HarborOne Mortgage, LLC, or HarborOne Bancorp, Inc. and their immediate family and persons living in the same household as employees, officers, directors, representatives, affiliates, and subsidiaries of those entities. Disputes: In the event of a dispute as to the identity of an entrant, the entrant will be deemed to be the applicable Authorized Account Holder. Qualifying HarborOne debit card point-of-sale transactions includes the following categories: in-person point-of-sale transactions, online transactions, Mobile Wallet transactions utilizing Apple Pay, Samsung Pay, or Google Pay. ATM transactions do not qualify. OR...
